

## **RULES OF PLAY**

- · USGA Rules govern all play except when modified by a local rule.
- Out-of-bounds is defined by white stakes, boundary walls and street curbs. Note: A ball
  that crosses a public road is defined as out-of-bounds even though it may come to rest on
  another part of the course.
- · Penalty Areas are defined by red stakes and/or lines.
- · Drop Areas are located on Hole 13.
- Tall Native Grass Areas are deemed through the green Relief without penalty is not
  available. To help with pace of play please play a provisional ball if your ball may have
  entered these areas.

## Additional Notes

- Carts are to remain on paths on all par 3's and around all tees and greens. Please observe the 90 degree rule while in the fairways. No carts in desert areas.
